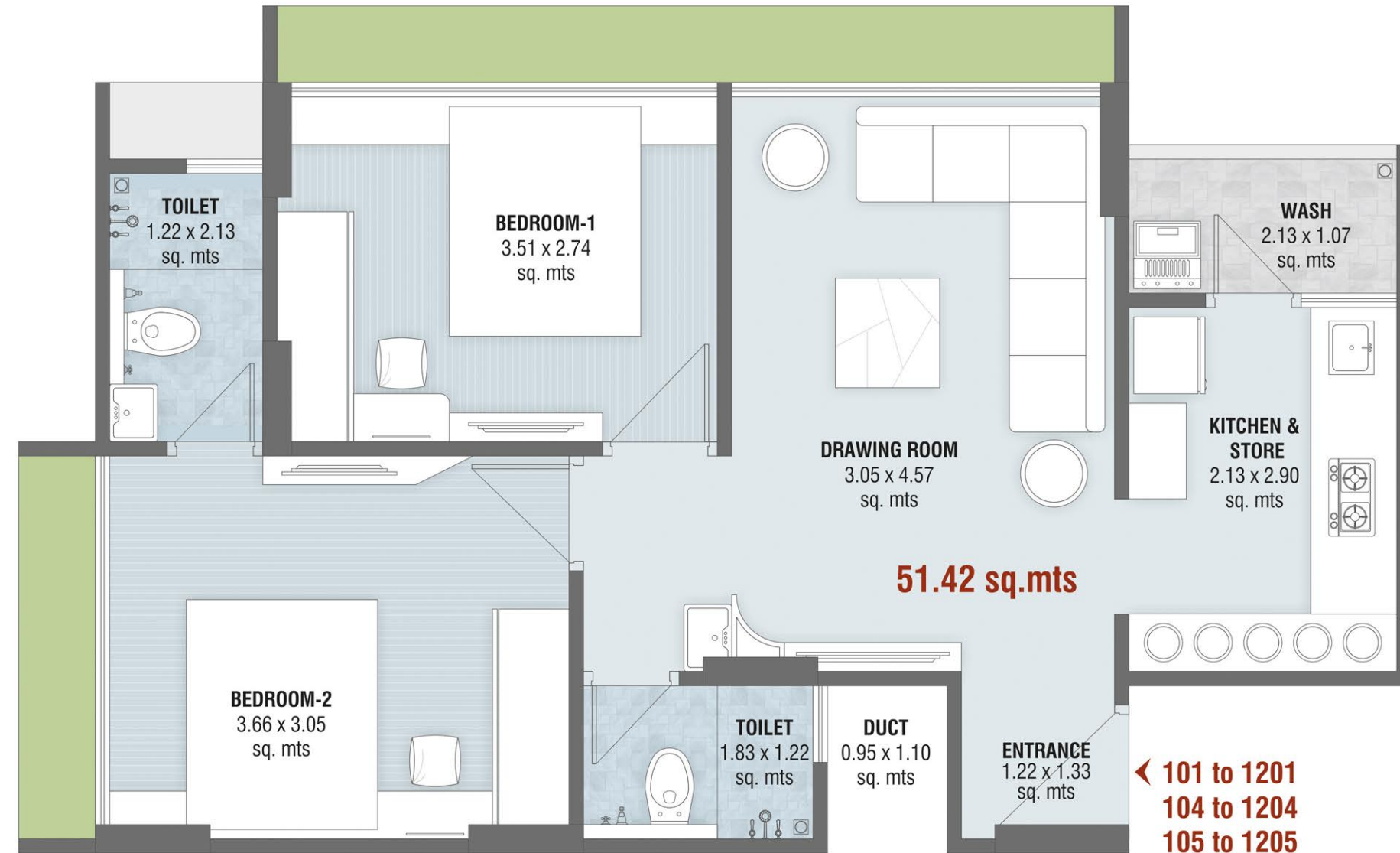
GROUND FLOOR PARKING LAYOUT



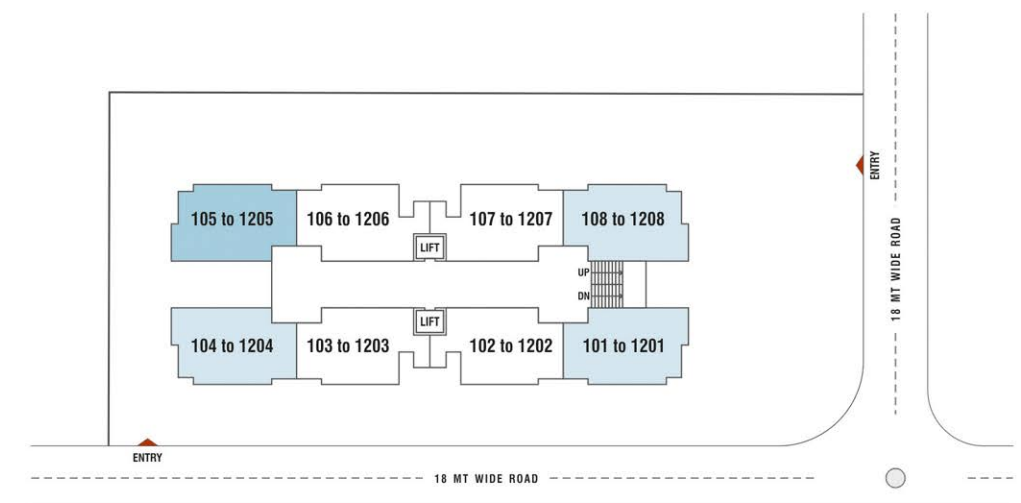
TYPICAL FLOOR LAYOUT



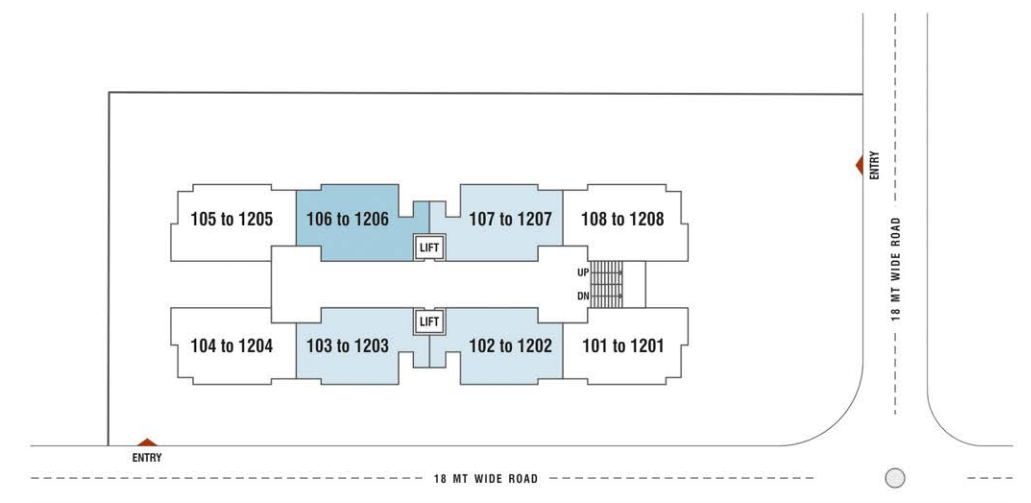
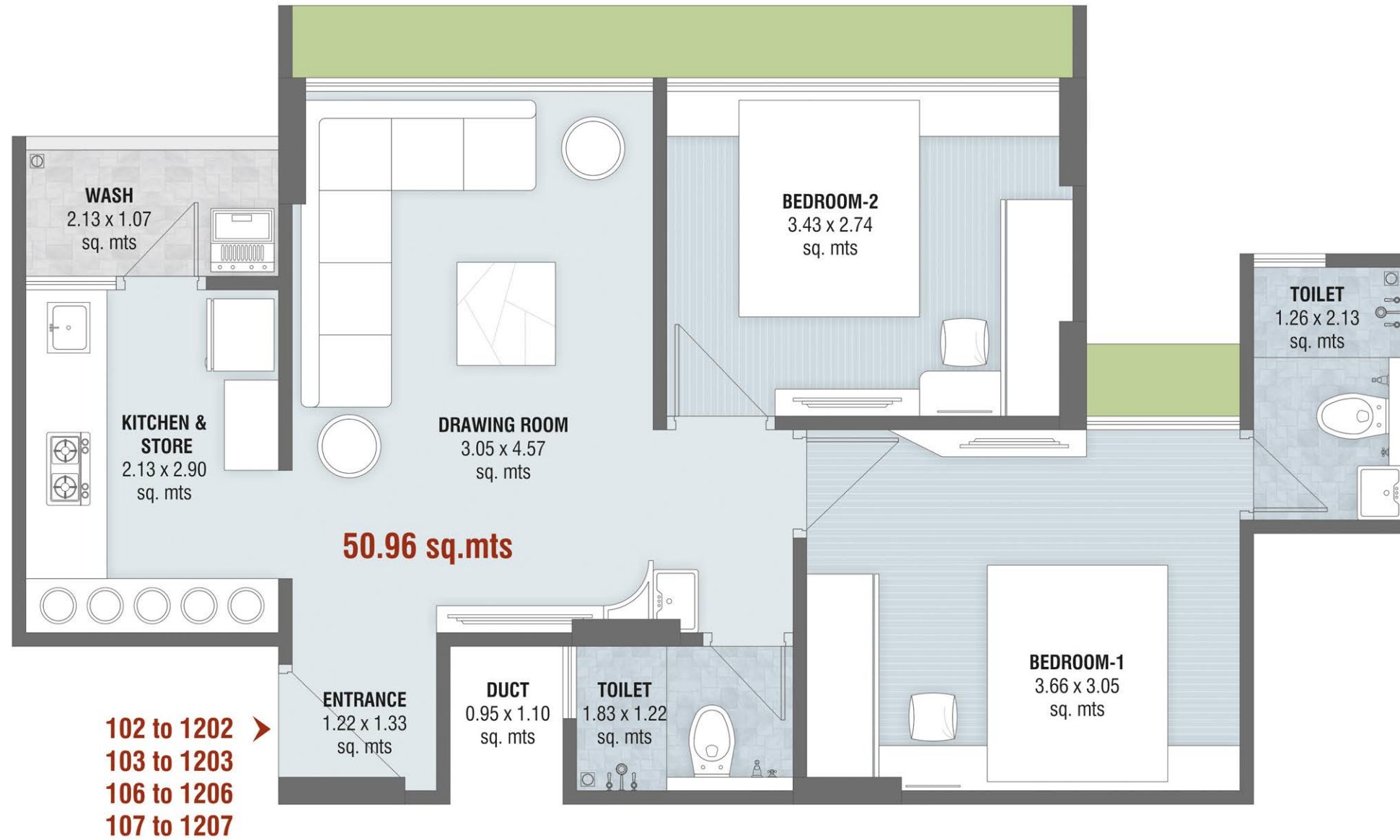
